CDI to deliver a new DAF unclassified system and upgrade existing DAF classified system as the foundation to support the Army's PTSD research.

The Woodlands, Texas (October 24, 2007) COMPU-DATA International, LLC (CDI) a leading provider of information management products, received orders to provide their DigitalAsset Finder™ (DAF) product to the U.S. Army Records Management and Declassification Agency (RMDA). DAF aggregates structure to disparate and unstructured data and supports researchers in search and retrieval discovery. DAF will serve as the primary information management infrastructure supporting important Post Traumatic Stress Disorder or PTSD analysis work being done at the U.S. Army RMDA Joint Services Records Research Center (JSRRC) division for the veterans of the United States Armed Forces.

The capabilities in our DAF product will deliver the information management functionality to the JSRRC that will help them in servicing our veterans in a more efficient and responsive manner." said Juan J. In early 2007, the RMDA began using DAF to support the JSRRC's research on classified data. The order announced today will grow the classified system to support an additional 20 terabytes of data growth. A second DAF instance will support the research on unclassified data. Both systems will provide analysts with information management, records preservation, collaboration and administration of digital assets while rapidly delivering relevant, multi sourced information gathered from disparate data sources available from multiple government agencies. Options available in the DAF product include automatic categorization, PDF file management, reporting, audit trails and extensive security.

"With DigitalAsset Finder™ and CDI's commitment to excellence we will ensure that the JSRRC will have the best tools and technology to support their business process and achieve their goals." Celaya went on to say, "Our continued success with RMDA and our other customers demonstrate why we are just months away from celebrating our twentieth anniversary."

In addition to other related functions, RMDA manages the Army's Records Management Program which include the following segments: The Army Records Information Management System (ARIMS), Rulemaking, Correspondence, Official Mail and Distribution, Terminology, Abbreviations, Brevity Codes, and Acronyms, Vital Records, Special Records, and Compilation of Army Addressees; Army's records and files management, Freedom of Information/Privacy Act, Executive Order 12958 Declassification, and Electronic Records programs.
